## **REACH! Guest Information and Expectations to Prom May 2026**

Attention Scholars and Parents: For the safety and comfort of all Prom attendees, REACH! Partnership has established the following prom contract. Please read the following information carefully.

This contract must be signed by the attendee's school administrator, parent and student. Failure to obtain any signature will deny entry for the guest into the prom.

Cost for guests: \$50.00 (cash or money order made out to REACH! Partnership – Prom)

**No guest permitted over the age of 21**

**One (1) guest per REACH! Student**

### **Dress Code**

#### **Young ladies must adhere to the following requirements when considering dresses:**

- Formal Attire – strapless and spaghetti straps are permitted
- Your breasts should not be exposed – cleavage with no more than 2 inches showing
- Dresses should not reveal more than 5 inches of leg above the knee
- Shoes must be worn at all times (bring a second, more comfortable pair of shoes)

#### **Young men must adhere to the following requirements when considering attire:**

- Formal Attire – dress pants, button up shirt and tie, suit or tuxedo
- Shirts must always remain on and buttoned
- No Jeans and shoes must be worn at all times
- No baseball type hats, bandanas/du-rags or large chains

REACH! Partnership administration will determine any dress code violations and entry may be denied if attire is deemed inappropriate or if prom attendees choose not to comply. Dress code rules are in place for the duration of prom. Altering attire once in the venue will result in removal from the prom.

Prom attendees who are unsure if their attire meets the above dress code are encouraged to see the following class advisors for approval: Young men see Major Hall or Coach Money. Young ladies are to see Ms. Rose, Ms. Ware or Ms. Kim. Final approval must be secured by Mr. French.

All prom attendees are subject to a search of coats, jackets, suits and purses before entering the prom venue. Failure to be searched will result in refusal of entry into the prom venue. Parents/guardians are

not permitted in to the prom venue. Any illegal substance or item or weapon will be confiscated and may cause denial of entry into the venue.

**Behavioral Expectations**

- All rules and policies of REACH! Partnership and the Baltimore City School Code of Conduct will be enforced.
- Any prom attendee who displays signs or behaviors of being under the influence or in possession of any illegal substance (alcohol, illegal drugs and/or tobacco or vape products) will be denied entry into the prom and/or removed from prom and disciplinary action taken by school administration and school or local police.
- ALL prom attendees must present their assigned ticket at the prom entrance. No exceptions.
- Once students leave the event, they will not be permitted back in the building
- Guest must be accompanied by the REACH! student listed above who purchased a ticket
- There will be no refunds for prom attendees that are denied entry to the prom or removal from the prom.

**Prom Agreement**

By purchasing a prom ticket, I agree to comply with all guidelines and expectations outlined above. I understand that it is my responsibility to read and understand this prom contract (both guest and REACH! Partnership student). I acknowledge, understand and will accept any consequence for inappropriate behavior.
